- Addressing Disproportionality in AL Public Schools (Lee vs. Macon): Component 3: Make Sense Strategies (MSS) Training

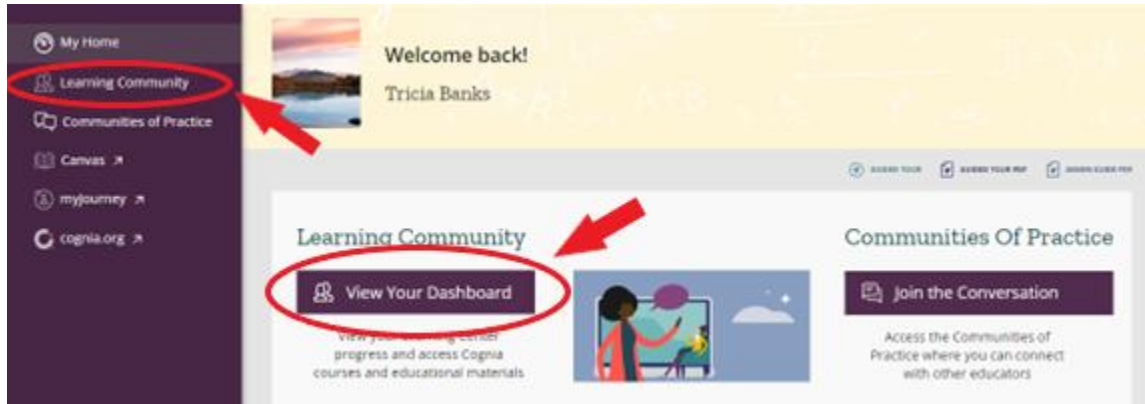

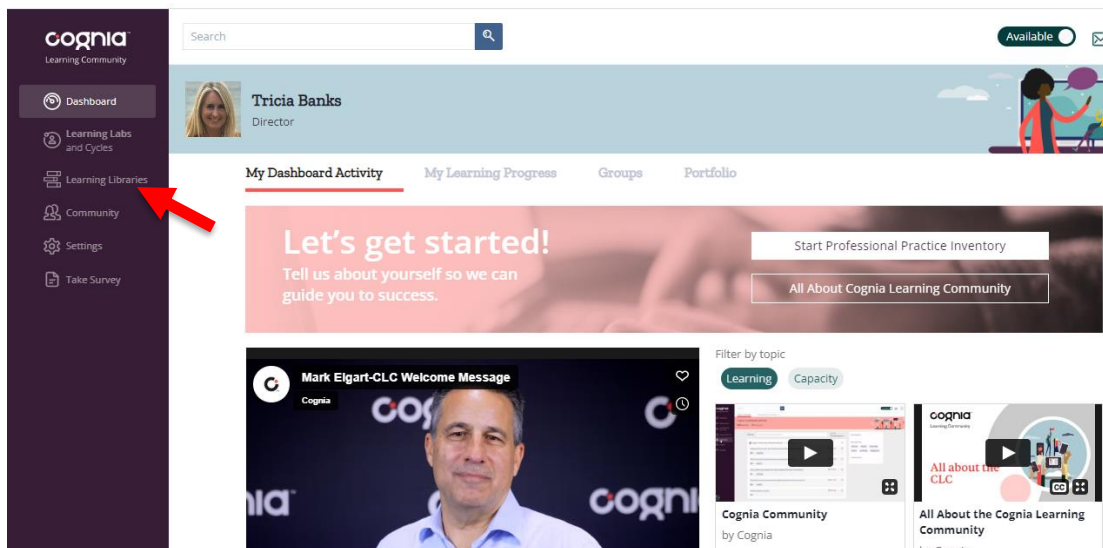

**Step 2:** Notify your staff. Once your teachers are uploaded into [Cognia Home](#), they will receive an automated email to help them set up their account. Send your staff this email, [Mandatory Training Library Email Template for Teachers](#), to notify them of the registration email and how to access the training labs.

**Step 3:** Navigate to the Cognia Learning Community. From the Cognia Home portal, choose one of the two options below to access the Learning Community platform.



**Step 4:** Locate the Mandatory Training Library. Choose **Learning Libraries** from the left navigation panel. Choose the **Alabama Mandatory Training Library 2024-25** to get started exploring the nine Learning Labs available.
